- * I have not traveled internationally within the last 14 days.
- * I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- * I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- * I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Douglas County Youth Orchestra harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the **DCYO & Fall 2020 Play-a-thon**, or that may otherwise arise in any way in connection with any activities organized by Douglas County Youth Orchestra. I understand that this release discharges Douglas County Youth Orchestra from any liability or claim that I, my heirs, or any personal representatives may have against the **DCYO & Fall 2020 Play-a-thon** with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Douglas County Youth Orchestra.
